Dear Mr. Lavery:

The application for amended registration of the subject product in support of continuing registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following conditions:

- 1). The signal word DANGER must be larger than Keep Out Of Reach of Children (KORC). Since your label is over 30 square inches, DANGER must be at least 18 point size type and the KORC hazard must be at least 12 point size type. Refer to 40 CFR§156.60.
- 2). You must modify the Environmental Hazards statement by deleting all but the first sentence because the NPDES statement is not required for a product under 5 gallons or 50 pounds.

Because your product is distributed in a 4 pound container, Certification of Child Resistant Packaging must be submitted in accordance with 40 CFR§ 157.20. Tom Luminello spoke with you on June 18, 2003 and you indicated that your package was not in CRP as required and from your description of your market that it did not qualify for as an Industrial use product.

A copy of your conditionally approved label is enclosed. You must submit a copy of the final printed label for the file as well as the other information cited above. If you have any questions about this letter, contact Tom Luminello of my staff at (703) 308-8075.

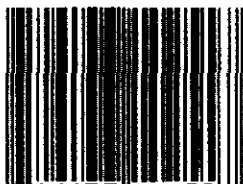

DIRECTIONS

It is a violation of Federal Law to use this product in a manner inconsistent with labeling.

1. Clean and rinse all equipment.
2. **SOFT ICE CREAM FREEZERS:** SPUR-TEX SC (6 level Tbs.) and operate beater 5 to 6 minutes and wipe or brush if necessary. Check and wipe or brush if necessary. minutes with 2 oz. SC (4 level Tbs. chlorine). Drain and air dry.
3. **SANITIZING RINSE** -- 3 glasses whenever possible. Rinse with clean potable water. SPUR-TEX SC (5 level Tbs.) at least 2 minutes or for commercial utensils on a rack or drainboard.
4. Cleaning and Deodorizing sinks and refrigerators: Use SPUR-TEX SC (5 level Tbs.) (920 ppm available chlorine) solution to contact surface.

For removal of hardened deposits use SPUR-TEX SC Cleaner as a scouring powder.

Do not use on resilient tile, linoleum, or vinyl.

Make up fresh SC solution as needed. Do not re-use solution.
