STORAGE: Keep product in tightly closed original container when not in use. Store in a dry, well ventilated area. Product should be stored at 50°F, or above.

DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Triple rinse the drums (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incinerate. Burn only if allowed by state and local authorities. If burned, stay out of smoke.
