Technical Piperonyl Butoxide* 1.50%
Pyrethrins30%

DIRECTIONS FOR USE

1. Remove protective cover. Holding dispenser upright, point valve in the desired direction and press dispenser button to spray.
2. Close room, leave closed and unoccupied for 15 to 30 minutes after spraying.
3. When used in enclosed areas, do not remain in treated areas. Ventilate area after treatment is completed.
4. Cover exposed food before spraying. Avoid excessive spraying toward light walls. DO NOT spray plastic or asphalt tile direct.
5. Bomb will operate about six minutes. Count one second, two seconds, etc., to prevent waste. Do not turn upside down.

MOSQUITOES, FLIES, GNATS: Spray with upward motion of arm 4 to 6 seconds per 1,000 cu. ft. (10'x10'x10') walking around room to spread mist.

ROACHES, WATER BUGS, SILVER FISH: Direct spray at cracks and crevices, open drawers and cabinets and move contents to reach insects with mist. Spray under side of sinks, bath tubs, drains and in damp places. Concentrate spray around their hiding places. Repeat application as necessary. Follow directions, excessive spraying is wasteful. Non inflammable. Easy to use.

CAUTION KEEP OUT OF REACH OF CHILDREN

AVOID INHALATION

Do not spray on the skin or animals. In case of skin contact, wash with soap and water. Avoid contamination of feed and food stuff. Remove birds, fish and pets from room being sprayed.

WARNING: Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 130° Fahrenheit may cause bursting. Never throw container into fire or incinerator.

Use this product as a space spray in food processing plants only when plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using.
