CLEAN

- For normal cleaning, mix 1/4 cup to 1 gallon hot water. Use as directed. This product will leave surfaces clean and shiny. No rinsing required.
- For tough cleaning jobs - lipstick, scuff marks, tar, hardened grease, whitewall tires - wear rubber gloves, use full strength and wipe immediately.

DISINFECT

- To kill *Staphylococcus aureus* (Staph) [ATCC 6538] and *Streptococcus pyogenes* (Strep) [ATCC 9342] germs* and athlete's foot fungi *Trichophyton mentagrophytes* (AFF) [ATCC 9533], on environmental surfaces, wipe with recommended solution (1/4 cup to 1 gallon water) until surface is thoroughly covered. Let stand for 10 minutes, then remove excess.

DEODORIZE & MILDEWSTAT

- To remove mold and mildew and the odors they cause from hard non-porous surfaces, clean surfaces with solution (1/4 cup to 1 gallon water) and reapply thoroughly with a damp cloth. Let stand for 10 minutes, then remove excess. Repeat application as necessary to maintain control.
