The following amendment, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the following comments.

Proposed Amendment

- Add three (3) organisms to label: Escherichia coli with extended beta-lactamase resistance, Escherichia coli O157:H7, and Community Acquired Methicillin-Resistant Staphylococcus aureus
- Revision of Storage and Disposal Statement
- Addition of marketing claims

Acceptable Data

The proposed label claims are acceptable regarding use of the product, Tilex (EPA Reg. No. 5813-24), as a disinfectant against the following microorganisms on hard non-porous surfaces. Directions were not provided for bactericidal claims consistent with the data. The registrant must add the appropriate use dilution.

Labeling Comments

- 1. The following claims must be removed from the proposed label:
 - Kills 99.9% of household mold
 - Kills 99.9% of household mold and mildew in just 5 minutes
 - Kills most common household molds
 - Attacks mildew at its roots
 - Kills mold and mildew at its roots
 - Seeks out and kills mildew at its roots
 - Seeks out and kills mildew even in hard to clean places
 - This product penetrated deep beneath the surface

- 2. You must clarify the claim for cement pool areas. Specifically, you must state whether the claim is for cleaning, disinfection against bacteria, or against mold/mildew.
- 3. On the proposed label, you must change "E. coli 0157:H7" to "E. coli 0157:H7".
- 4. On page one of the product label, you must remove the graphic of your other product "Ultra Clorox". This graphic implies that the two products have the same efficacy, and is therefore misleading.
- 5. Revise the Precautionary Statements to read as follows: "Causes substantial but temporary eye injury and skin irritation. Do not get in eyes, on skin or on clothing. For sensitive skin or prolonged use, wear gloves. Harmful if inhaled. Avoid breathing vapor and use only in well-ventilated areas. May be harmful if swallowed." The statement "Not recommended for use by persons with heart conditions or chronic respiratory problems such as asthma, emphysema or obstructive lung disease" is currently unjustified by data and must be deleted.
- 6. In accordance with PR Notice 2007-4, the Agency defines "refillable" as follows:

"Refillable container" means a container that is intended to be filled with pesticide more than once for sale or distribution. The registrant determines whether a container is intended to be refilled for sale or distribution (in which case it is a refillable container) or if it is not intended to be refilled for sale or distribution (in which case it is not a refillable container) and implements its decision by labeling the container appropriately. This decision also would impact packaging design, packaging material, and distribution and marketing plans.

Please consider whether your containers meet our definition of refillable. If it is not your intention for this product to be marketed in containers which are returned to the distributor for refill and resale, then delete the language relevant to refillable containers, within the Storage and Disposal statement.

- 7. You must revise all Storage and Disposal language for Nonrefillable containers to include the following statement: "Nonrefillable container. Do not refill or reuse this container."
- 8. You must move the "Directions for Use" heading and accompanying advisory statement to the top of page two.
- 9. Should you wish to add/retain a reference to the product or company's website on your label, please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

10. You must delete the claim "Pool and outdoor areas" from page three of the label. This claim is too vague and can imply use sites other than those registered for this product.

A stamped copy of the labeling, accepted with comments, is enclosed. Submit one (1) copy of your final printed label before distributing or selling the product bearing the revised labeling.




