

TOILET BOWLS. . . .Pour 2 1/2 oz. in bowl and brush thoroughly, including the rim.

GENERAL CLEANING: Add 1/4 cup per gallon of water. Usually no rinsing needed.

This product is safe on most washable, non-porous surfaces. For best results, test a small area before application and vary concentration as needed. Not recommended for wood. Only use diluted on no-wax floors. Rinse rubber or asphalt after use.

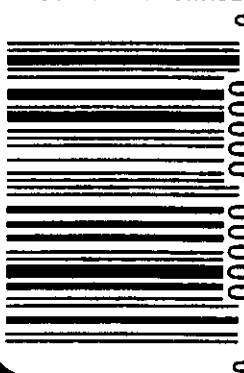
AUTOMOBILES. . . .Use 1/4 cup per gallon of water for cleaning, sponge and rinse. Use full strength on a sponge for spots and on whitewall tires, then rinse.

PRECAUTIONARY STATEMENTS
