To Clean: Mix $1 / 4$ cup of this product with one galion water. Apply directly with [damp] sponge -or- mop -orcloth -or- rag. [Rinse or wipe clean.] [Allow to air dry.] For really stubborn spots, wear rubber gloves and use direct from the bottle, rinsing immediately. On food preparation surfaces, follow with potable water rinse. To Disinfect: Mix $1 / 4$ cup of this product in one gallon water. Apply directly with [damp] sponge -or-mop -orcloth -or- rag and wet surface[s] completely. Let stand 5 minutes. [Rinse or wipe clean.] [Allow to air dry.]
