MOLD & MILDEW PREVENTION: Use 1/4 cup per gallon of water, thoroughly moistening the affected area. Repeat treatment during your regular cleaning or as necessary. Effective for up to 30 days.
TOILET BOWLS: Pour 1 1/2 ounces in bowl and brush.
DIAPERS: Pre-soak in 1/2 cup of this product per gallon of water, prior to routine laundering.
FOR SPECIAL CLEANING AND DEODORIZING TASKS:
EXTRA TOUGH JOBS: Use full strength with mop or sponge and rinse.
