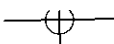

CLEANING AND DEODORIZING

FOR FLOORS, WALLS AND SIMILAR SURFACES. Dissolves old wax, greasy grime and film... even removes crayon marks. Use 1/4 cup per gallon of water. No rinsing required, except on rubber or asphalt tile. For extra tough jobs, use full strength and rinse immediately.

NO-WAX FLOORS...When used as directed, this product will not harm no-wax floors. Use 1/4 cup per gallon of water; wash floor with mop or sponge and rinse. For no-wax floors, this product is not recommended for use at full strength.

KITCHEN...Kitchen floors collect grease and traffic dirt. Use 1/4 cup per gallon of water, or full strength anywhere greasy dirt is a problem.

BATHROOM...Great for cleaning and sanitizing basins, tubs, and tiles. Leaves everything bright and clean - kills household germs. Use 1/4 cup per gallon of water, or full strength where odors are a problem.

TOILET BOWLS...Pour 2 1/2 oz. in bowl and brush thoroughly, including under the rim.

DISINFECTS AGAINST HOUSEHOLD GERMS

Kills household germs...On hard, non-porous household surfaces such as kitchen and bathroom floors, toilets, diaper pails and pet areas. Use 1/4 cup per gallon of water. Wet surfaces, let stand for 10 minutes, then remove excess. For highly soiled areas, clean excess dirt first.

SPECIAL CLEANING AND DEODORIZING APPLICATIONS

LAUNDRY...Pour full strength on grease spots, collar and cuff stains or other soiled areas and rub in before loading into the washer. For extra cleaning power and deodorizing during the wash, add a half cup of this product along with your regular soap and detergent.

GARBAGE CANS...Use full strength or 1/4 cup per gallon of water to clean and deodorize. Brush and rinse.

AUTOMOBILES...Use 1/4 cup per gallon of water for cleaning; sponge and rinse. Use full strength on a sponge for spots and on whitewall tires, then rinse.

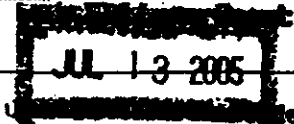
