Dear Ms. Saiki

The following amendment submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the conditions listed below.

- Revise First Aid Statements per 2001-1

### Conditions

Revise the label as follows:

1. Revise surfaces, refrigerator and small appliances to read refrigerator "*exteriors*" and small appliances "*exteriors*."
2. Under "Bathroom," qualify ceramic tile as a hard non-porous surface by stating "*glazed*" ceramic tile. Also, delete toilet bowls because there are no directions and data to support the use.
3. Under "Outside," qualify the outdoor furniture as hard nonporous by stating "*non-wood*" outdoor furniture.
4. Revise the "disinfecting" directions by stating "Pre-clean first. Spray evenly 6-8: until thoroughly wet. Let stand for 10 minutes, then allow to air dry or remove excess liquid with cloth, mop, or sponge."


5. Revise the "storage and Disposal" statements to read "Store in a secure area inaccessible to children. Do not reuse empty container. Discard in trash if recycling is not available."
