This is to acknowledge receipt of your Amendment submitted in conjunction with section 3 (c) 7 a of the Federal Insecticide, Fungicide, and Rodenticide Act. as amended, is acceptable subject to the following conditions.

The Agency has taken into consideration your letter of April 23, 1998 and will allow the phrases "Contains No Bleach" and "Citrus Scent". The Agency will further allow the phrase "Commercial Solutions" with the understanding that it, along with the phrases "Institutional Size" and "Industrial Size" will only be used on this line of products when they are being sold to the institutional market.

Since this product is for use on hard non-porous surfaces, the following two sites must be removed from the label: "grouting" and "carpet". The following sites should be qualified: change "ceramic tile" to "glazed ceramic tile", change "porcelain tile" to "glazed porcelain tile", and specify the type of woodwork on which this product may be used.

The following organisms may be referenced on this label: Salmonella choleraesuis and Staphylococcus aureus since you have previously provided data to support these claims. Data to support Aspergillus niger should be kept in your files for reference by the Agency if needed at a later date.

The Agency requests that the ingredients statement be placed on the front panel since there is adequate space.

Revise your "Precautionary Statements" as follows.

"WARNING: Causes substantial but temporary eye injury. Harmful if absorbed through skin. Harmful if inhaled. Avoid breathing spray mist. Do not get in eyes on skin or on clothing. Wear safety glasses or goggles. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

Revise the "Statement of Practical Treatment" as follows.

"IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting or give anything by mouth to an unconscious person. Drink promptly a large quantity of milk, eggwhites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol."

Revise the phrase: "Safe for septic systems-or-tanks" to read "Not harmful to septic systems-or-tanks". Remove the phrase "Safe on most-or-all surfaces". Since this product cannot be used on all surfaces, revise this phrase as follows "Not harmful for most surfaces". The Agency feels that the use of the word "safe" is false and misleading.

You have not provided us with container size information since March 30, 1994. In the future, be certain to complete Section III of the Application for Registration form 8570-1. If you are still marketing this product in 16 oz and 32 oz sizes, your product would fall within the definition of a "domestic use". The following statement would continue to apply if your containers are no larger than one gallon. Therefore your "Storage and Disposal" statement should be revised as follows. A separate statement is not needed for institutional use if you continue to market in sizes of one gallon or less.

"STORAGE AND DISPOSAL

Keep container closed. Store in the original container in an area inaccessible to children and pets.

Securely wrap original container in several layers of newspaper and discard in trash."
