PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Highly corrosive. May be fatal if swallowed. Do not take internally. Causes eye and skin damage. Do not get in eyes or on skin or clothing. Wear safety glasses, protective clothing and rubber gloves. Wash thoroughly after handling and before eating, drinking, chewing gum or using tobacco. Remove and wash contaminated clothing before reuse.

PHYSICAL AND CHEMICAL HAZARDS: Strong oxidizing agent. Mix only with water. Once the product is placed in the water tank of the toilet, do not remove until all material has completely dissolved.

FIRST AID: IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. **IF ON SKIN:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. **IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything to an unconscious person. **IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice. Have the product container or label with you when calling a poison control center or doctor or going for treatment.

This product keeps your toilet bowl clean for at least one month. Its active ingredient reduces germs in toilet bowl water by 99.9%, after each flush. This product is a unique system that dispenses cleaning and bleaching ingredients with every flush, eliminating the need for frequent scrubbing. This product is safe for plumbing, fits most tanks, and is easy to use. Water remains crystal clear so that you see the clean. Bowl water can be used for diaper rinsing. Use in all toilets in the home.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

With an average usage of ten flushes per day, this product will be an effective sanitizer for one month.

Thoroughly clean toilet bowl surfaces, especially under the rim, prior to installation of this product. Remove toilet tank cover and immerse this product so it hangs upright close to the bottom of the tank. Adjust the hanger and hook it over the edge of the tank near the center of either the front or the back well. Replace cover. Replace after one month or 300 flushes. Unusual situations may cause stains to appear over time. When this occurs, flush, brush bowl surface with bowl water, then flush again.

STORAGE AND DISPOSAL:

Store in original container in areas inaccessible to small children in a cool, dry, well-ventilated area. Wear rubber gloves for disposal. Carefully lift product. Hold over tank and tip to drain all water from each hole. Water contains bleach. Avoid contact with solution. Wrap in plastic bag and discard in trash. Do not crack dispenser.

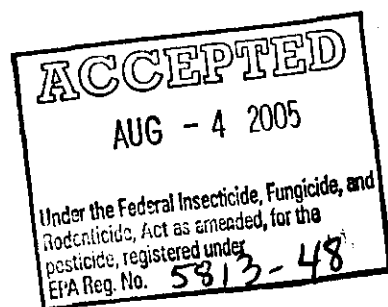
