Dear Ms. Lawson:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the comments listed below:

**Proposed Amendment:**

- Expanding certified limits for all inert ingredients on fifteen basic and alternate Confidential Statements of Formula

**Comments on Confidential Statements of Formula:**

1. The registrant must change "page 1 of 2" to "page 1 of X" in box "B" of the CSF. "X" stands for the total number of pages including the attachments.
2. The CSFs contain a pre-reaction. Therefore, the present of the diluent is to be expected. The chemical mass balance has nothing to do with the finished product composition. Once the chemical reaction takes place and is in equilibrium then the post-reaction becomes a mixture in which the diluent is added. The diluent is a stable molecule. Therefore, the certified limits for the diluent must be calculated using the EPA standard certified limits.

**Comments on Product Label:**

1. On page one (1) of the product label, you must replace the partial First Aid language with the complete First Aid Statement, as currently shown on page two (2). The product has been categorized as Toxicity Category I, therefore the First Aid Statement must appear on the front page on the label.
2. On page one (1) of the product label, you must include the Batch code or Lot number.

3. On page two (2) of the product label, you must revise the Precautionary Statements to read as follows: "DANGER: Corrosive. Causes irreversible eye damage and skin burns. Harmful if swallowed. [Specify appropriate protective clothing and eyewear.] For prolonged use, wear gloves. Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Avoid breathing vapors, and use only in a well-ventilated area.
4. On page two (2) of the product label, you must include the following additional Environmental Hazards Statement: "[For containers less than 5 gallons:] ENVIRONMENTAL HAZARDS: This product is toxic to fish, aquatic invertebrates, oysters and shrimp." You must also revise the first line of the Environmental Hazards Statement for products 5 gallons or greater to the above text.
5. On page two (2) of the product label, you must revise the Storage and Disposal Statement to remove the word "please" from the statement "Please recycle empty container or discard in trash."
6. On page three (3) of the product label, the heading "Environmental Commitment" is considered false and misleading and must be removed.
7. On page three (3) of the product label, the phrase "Contains no phosphorus or phosphates" must be removed. Statements or claims that express the absence of certain ingredients may be misleading statements prohibited by 40 CFR 156.10 (a)(5). These claims are examples of a true statement used in such a way as to give a false and misleading impression to the purchaser. Further, a product must not claim that it does not contain an ingredient if it never contained or was likely to contain the substance in the first place.
8. On page three (3) of the product label, the statement "This product rapidly breaks down almost entirely to salt [and] water" is too vague, and is considered false and misleading.
9. On pages four and five of the product label, the following temporary comparative marketing claims have been on the label for more than six months without a relevant formula change. These claims must be removed from the product label: "Better smell", "Better smell[ing] [scent] [fragrance]", "Gets whites even whiter than before after multiple washes", "Improved Whitening", "Better odor", "More bleaching power" and "Ultra-Improved".
10. On pages four and five of the product label, the following claims are considered comparative and must be removed: "Clorox for a higher standard of clean", "Concentrated formula for unbeatable whitening", "[Many] [Most] Manufacturers recommend regularly washing out your HE [High Efficiency] machine with [HE] [High Efficiency] bleach -or- [this product]", "Recommended by Whirlpool", "Use for a higher standard of clean", "essential for the purest clean", and "Since HE machines work differently, it is optimal to use a specially formulated bleach... [like Clorox Bleach.]"
11. On pages four and five of the product label, the following claims are considered to imply heightened efficacy, and must be removed: "Clorox Bleach goes Ultra", "The Power of Clorox Bleach", and "The power -or- brand you trust".

12. On pages four and five of the product label, the claims that the product will not harm aluminum, steel and silver are contradictory to the statement on page nine: "DO NOT USE ON STEEL, ALUMINUM, SILVER OR CHIPPED ENAMEL". The proposed statements are not acceptable and must be deleted.
13. On page four (4) of the product label, the claim "Removes what you can see [, what you can smell,] and what you can't [see]" is too vague and must be deleted.
14. On page five (5) of the product label, the following claims are considered false and misleading, and must be removed: "Ultra Clorox Bleach is safe for many color-fast washables" and "Most white fabrics and some colored fabrics can be safely washed with this product".
15. On pages five, six, ten and twelve of the product label, you must remove the new use "Disinfecting toys". This use includes soft, porous surfaces, as specified in the Directions for Use on page ten, and therefore is not acceptable.
16. On page six (6) of the product label, you must remove the claim "Flu Fighter[s][!]"
17. On pages six and eight of the product label, you must not delete "ATCC VR-1147" from the product label. The ATCC designation is not optional on the Master Label reviewed by the Agency.
18. On page ten (10) of the product label, you must remove the following language from the subheading "Washer -or- Recharge Instructions": "To clean and recharge the Antimicrobial Power". The phrase "Antimicrobial Power" implies a heightened efficacy.
19. On page fourteen (14) of the product label, under the subheading "Loading and Hauling Equipment", the word "should" must be changed to "must".
20. On page sixteen (16) of the product label, under the subheading "For Dairy and Creamery Equipment Station", the word "should" must be changed to "must". You must also revise "It is important to clean out large deposits of milk..." to read "You must clean out large deposits of milk..."
21. On page nineteen (19) of the product label, under the subheading "For Food Egg Sanitation", the word "should" must be changed to "must".
22. On pages six, twenty and twenty-six of the product label, you must revise "Kills Avian Influenza A virus on precleaned environmental surfaces" to read "precleaned hard, non-porous surfaces".
23. On page twenty-two (22) of the product label, under the subheading "For Sanitizing Solutions for Equipment and Utensils", the two instances of the word "should" must be changed to "must".
24. On page twenty-seven (27) of the product label, under the subheading "Disposal of Infectious Materials", the word "should" must be changed to "must".


25. On page twenty-eight (28) of the product label, under the subheading "Laboratory work areas, equipment and specimens", the wording must be changed to read "Workers doing the treatment must wear waterproof gloves."
26. On page thirty (30) of the product label, under the subheading "Karnal Bunt Quarantine Treatment Use Directions", both instances of the word "should" must be changed to "must".

**General Comments:**

1. The CSFs, dated 04/01/09, for the basic formulation is acceptable with comments, and supercedes all previously accepted CSFs. The registrant must incorporate the recommendations mentioned above.
2. The CSFs, dated 04/01/09, for alternate formulations # (A01, A11, and A20) are acceptable with comments. The registrant must incorporate the recommendations mentioned above.
3. The CSFs, dated 04/01/09, for alternate # (A01 & A02, A04, A07, A10, A11, A12, and A16 thru A22) formulations are acceptable.
4. A stamped copy of the labeling, accepted with comments, is enclosed. Submit one (1) copy of your final printed label before distributing or selling the product bearing the revised labeling.
