The labeling for the product referred to above submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy of the label is enclosed for your records.

- 1. In your Directions For Use section under the Disinfecting directions delete "or bacteria" in the phrase "Kills many bathroom and kitchen germs -or bacteria..."
- 2. On the front panel of your label in the paragraph "There are many uses for Spruce Ups and here are a few:... delete "almost any hard surface". This statement is too broad and must be quaified.
- 3. In your precautionary statements delete "Avoid (prolonged) contact with skin." If you want to add this phrase to this label then you would also need to require the use of gloves when using this product which may not be practical nor warranted depending on the results of a skin irritation study. The term "prolonged" would have to be better defined.
- 4. The "Use Outside the Home or Public Places" section must be deleted. In order to add those sites to your label you must specify the hard non-porous surfaces that the product can be used on. If you apply in the future to add those sites back to this label then the following statement must also be added to the label "Do not use this product on surfaces that will come in contact with food". Alternatively you can require a potable water rinse if you do not qualify and list the hard surfaces where the product can be used. We would assume that would include use on food contact surfaces. This would mean that you would have to delete the statements in your use directions: No rinse required. Let air dry.

- 5. Under "Disinfecting Claims" the following claims are unacceptable and must be deleted..
 - a. Cleans and (&) kills 99.9% of bacteria -and/or-(household) germs.
 - b. (The product are) the quick and easy way to clean and kill bacteria -and/or-(household) germs every time you wipe off a (household) surfaces. That's because they wipe away dirt and kill 99.9% of germs and bacteria with a bleach-free formula that is safe for surfaces.
 - c. This bleach-free formula (tion) clean dirt and kill 99.9% of bacteria (including ..."
 - d. After use, just throw the wipe(s) and germs-and/or-bacteria away.
 - e. Disinfects without spreading germs -and/or-bacteria away.

The use of the term "germs" for this product is not acceptable. In order to use the term "bacteria" you must list the specific bacteria that this product will control. The term bacteria is otherwise too broad.

- 6. The term (New) is allowed on a label for a 6 month period.
- 7. Under General Claims delete the following
 - a. Safe for (colored) surfaces
 - b. Safe for most surfaces.
