Q. What should I do if my mop leaks?

A. Check to see that the bottle connector is screwed on tightly to the bottle. Also make sure that the pad is not blocking the nozzle and that the nozzle is clicked securely in place on the front of the mop head.

Q. How much cleaner should I use? How long will one bottle of cleaner last?

For tough stains, use more cleaner and allow it to sit on the stain for a few seconds before mopping.
