1. According to the Label Manual, 3rd edition, all pests listed on the label must be identified by strain (i.e., ATCC number), therefore you must revise the list of organisms on page three and four by listing the specific ATCC or VR number, it must read as follows:

- Staphylococcus aureus (ATCC 6538)
- Salmonella choleraesuis (ATCC 10708)
- Salmonella enterica [ATCC 4931]


