Under When to Apply, change "seeds" to "weeds".

Under How to Apply, delete "Do not use on crops that will be used for food or forage purposes. Do not graze animals on treated areas. Do not contaminate water used for irrigation or domestic purposes". These statements are not appropriate for products used on turf.

Under Warranty Statement, delete "and turf". You are responsible for providing directions for use.

WEED CONTROL

2.4-D for Control of Broadleaf Plantain, Buckhorn Plantain, Dandelion, Pursiane, Pigweed and Smartweed. For Use on Turf except Desirable Clovers. Bent, St. Augustine, Dichondra and Carpet Grass.

WHEN TO APPLY

Use anytime seeds are actively growing and temperature is above 50 degrees F. Control is slower if weather is cool. Applications in Spring and Fall provide most effective kill. Apply when lawn is wet from rain, dew or sprinkling. On newly seeded areas, wait until grass has been cut two or three times. Delay planting new grass for at least 3 weeks as 2,4-0 may temporarily inhibit seed germination or plant growth. Do not apply when turf is under stress from heat, moisture or drought. Do not over of under apply.

HOW TO APPLY

Apply evenly over entire, lown area at the nate of 1/2 lb. per 1000 sq. ft. Use the suggested spreader settings as a guide being sure to check your spreader at the beginning of the application. Use only when there is no hazard of drift. Rain, sprinkling, or mowing within 24 hours may reduce effectiveness. Wait at least 2 weeks before making a second application.

Most Cases of groundwater contamination involving phenoxy herbicides such as 2,4-0 have been associated with loading and disposal sites. Caution should be exercised when handling 2,4-0 pesticides at such sites to prevent contamination of groundwater supplies. Placement of the spreader on an impervious pad to contain spills will help prevent groundwater contamination.
