DIRECTIONS FOR USE

Stir or shake thoroughly to mix contents. Wood should be dry and free from bark to allow best penetration. Soak wood for a minimum of three minutes or apply, liberally, two or more brush coats. All possible surfaces should be covered, especially end grains, joints, and those to be in contact with the soil. Fence posts should be soaked in preservative for 12 to 48 hours. For proper termite control, treatments should be made after all cuts have been made and before wood is used in the structure.


At least 24 hours drying time should be allowed before application of top coats.
