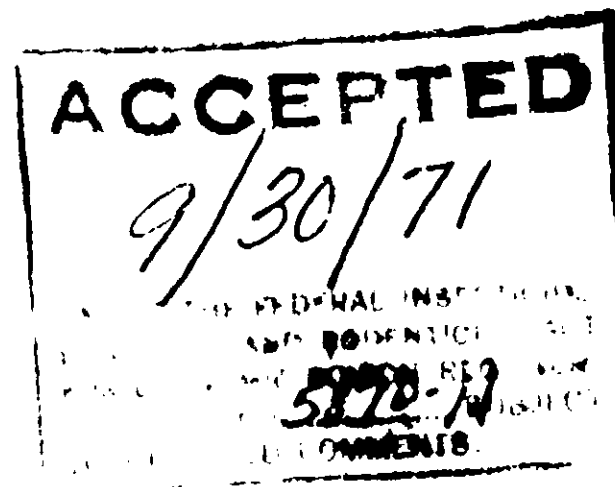
SPACE SPRAY INSECTICIDE

A high level, synergized pyrethrin type insecticide concentrate for space application by fogging and spraying machines and similar equipment. FOGICIDE can be used around food, food products, utensils and equipment provided that no exposed food is present and provided that food utensils and surfaces that will be in contact with food are covered and provided that fogging and spraying is not performed in food processing plants while plant is in operation.

Properly applied, FOGICIDE kills the accessible exposed stages of flies, ants, mosquitos, boxelder bugs, silverfish, fly-ing moths, gnats, crickets, roaches, spiders, scorpions, wasps, hornets, clover mites, cheese mites, cheese skipper, and most common stored-grain pests, including granary weevil, rice weevil, grain beetle, spider beetle, angoumois grain moth, Mediterranean flour moth and grain mites.

DIRECTIONS

Flying Insects

FLIES, MOSQUITOES, GNATS: Direct the spray toward the upper portions of the enclosure and fill the atmosphere with mist, using 2 to 3 ounces of the product to each 1,000 cubic feet of space. If possible, keep the doors and windows closed for 10 minutes after applying the spray.

Crawling Insects

(Exposed or Accessible Stages)

ROACHES, SILVERFISH, SPIDERS: Spray infected areas thoroughly and direct the liquid behind baseboards, moldings, cabinets, shelves, sinks, door and window frames and pipes, toward drains and dark corners, and into cracks, crevices, recesses and similar hiding places. Repeat as needed.

ANTS: Treat shelves, cabinets and storage areas. Spray ant runs, trails, baseboards, thresholds and other places of entry, and treat nests liberally.

FLEAS, TICKS: Direct the spray toward lower wall portions, baseboards, rugs, carpets and floors of infested areas. Spray animal quarters, kennels and the bedding of pets and other domestic animals.

BEDBUGS: Apply liberally to top, ends, sides and bottom of mattresses, spraying all tufts, seams and folds. Spray springs and frame, directing the liquid into all cracks, crevices and lock joints. Spray walls, baseboards, molding, floors, closets and bedroom furniture with special attention to protected bedbug hiding and breeding places.

CLOTHES MOTHS AND CARPET BEETLES: Remove infested articles from storage, brush thoroughly and, if possible, air several hours in direct sunlight. Apply spray liberally to all surfaces of empty chests, closets, bureaus and storages, directing the liquid into cracks, joints and crevices.

Do not remain in treated areas and ventilate the area after treatment is completed. FOGICIDE is an oil base material and should not be sprayed, stored or otherwise exposed to an open flame.
