DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Uniformly spray 1 gallon per 333 sq. ft. of soil surface or a strip 4 inches wide, 1,000 feet long, undiluted. Thoroughly wet all foliage to insure contact action. Best results are obtained when applications are made during or soon after weed emergence while growth is succulent. Where vegetation is tall and dense, use 1 gal. per 200 sq. ft., a strip 4 inches by 600 feet long. For control of hard-to-kill perennial weeds and grasses such as Johnsongrass, Bindweed and Wild Carrot, use 1 gal. per 83 sq. ft. Although EDGING LIQUID has considerable activity through foliar contact, much of its activity is through the roots and therefore adequate rainfall to move the chemical into the root zone is necessary.

Under conditions where the rainfall is high and the growing season long, a second application may be necessary to maintain a weed-free soil surface.

Care must be taken to keep this herbicide away from desirable flower beus, lawns or shrubs. Do not apply over roots of valuable trees, or woody ornamental plants. Only apply herbicide outside the drip line of trees.
