#### CAUTION

IF ON SKIN OR CLOTHING: Remove contaminated clothing and wash before reuse. Wash skin with soap and warm water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

### PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

TO KILL FLIES, GNATS, MOSQUITOES AND SMALL FLYING MOTHS:
Close all doors and windows and direct spray upward into center of room with slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Sweep up and destroy fallen insects. Before spraying cover exposed food and utensils.

TO KILL ANTS, CENTIPEDES, COCKROACHES, CRICKETS, FIREBRATS, SOWBUGS AND SPIDERS: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

TO KILL CARPET BEETLES: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. .... Repeat as necessary.

TO KILL EXPOSED FORMS OF CONFUSED FLOUR BEETLES, RICE ...
WEEVILS, AND SAW-TOOTHED GRAIN BEETLES: Find and destroy infested package goods. Remove all other items from Hantry. Spray the shelves to kill any of the named insects present.

Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

Remove and destroy pet's old bedding. To reduce infestation, thoroughly spray the animal's bedding, sleeping quarters, around baseboards, window and door frames, wall cracks, local areas of floors, and other resting places until the surface is slightly moist. Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also spray the entire inside surface of dog houses. Repeat as necessary. Put fresh bedding in pet's quarters after spray has dried. DO NOT SPRAY ANIMALS. Also treat dogs and cats with a registered flea and tick control product before allowing them to reenter treated area.

### STORAGE AND DISPOSAL

**STORAGE:** Store in a cool dry area away from heat or open flame.

<u>DISPOSAL:</u> Replace cap and discard container in trash. Do not incinerate or puncture.
