VEG-CLEAN is a pelletized non-selective weed and grass killer, designed for long-term control. It may be applied to the surface of the soil or mixed with water and sprayed to plant foliage. The product is formulated for use on non-crop areas where barren soil is desired. Some of these areas are storage yards, industrial sites, around utility poles, railroad berm, highway shoulders, around substations, and similar areas where vegetation might create unsightly or fire hazardous conditions.

**DIRECTIONS**

**DRY APPLICATIONS:** Use VEG-CLEAN directly from the bag or dispense with a seeder, power spreader, coffee can or other containers that will allow even distribution of the product. Before applying, measure area to be treated and select the rate for desired treatment. Calibrate over a small area and get even coverage with the rate selected. Rainfall is required to dissolve the pellet. Allow a few days after the pellet has dissolved for the results to appear.

**SPRAY APPLICATION:** Use VEG-CLEAN as a spray for quick knock-down of existing vegetation. Thoroughly cover all parts of the plant and spray to the point of run-off. For best results, completely dissolve the product in a small amount of water prior to pouring into the spray tank. Use spray equipment with mechanical agitation. It is possible to dissolve up to 3 lbs. of VEG-CLEAN in 1 gallon of water, etc.

**SPOT APPLICATION:** Use VEG-CLEAN dissolved in proper quantity of water and apply with a sprinkler can or other suitable dispenser.
