RECOMMENDATIONS

COTTON: Cotton Fleahoppers. Overwintered Boll Weevils. Thrips-- Use 8-10 lb. per acre. Make 2 to 4 applications at 7-10 day intervals. Use maximum dosage if boll weevils are present. Cotton Leafworms. Fall Armyworms. Fleabeetles. Grasshoppers. Lygus and other Mirids-- Use 10-15 lb. per acre. Apply as needed at 7-10 day intervals. Boll Weevils. Bollworms. Cutworms. Garden webworms--Use 15-20 lb. per acre. Apply at 4 to 5 day intervals until control is obtained. Stinkbugs--Use 20 lb. per acre.
