Subject: Amendment - Update Storage & Disposal directions Diazinon AG500 EPA Registration Number 5905-248 Your submission dated October 2, 1997

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- a) Add the heading Engineering Control Statements above the paragraph beginning "When handlers use closed systems...".
- b) In the ENVIRONMENTAL HAZARDS text, delete the comma after "(ducks or geese)".
- c) Relocate the Cranberry irrigation water statement from beneath the Non-Agricultural Use Requirements block to appear instead as the fourth item of the Notes for the crop Cranberries.
- d) In the introductory paragraph under the heading FRUIT AND NUT CROPS, delete the underline running from "of water" to "spray applied". Also, in the water gallonage table that follows, delete the underline from the Grapes entry and relocate the column headings appearing between the entries for Plums and for Prunes to appear in their correct location at the top of the page.

- e) Under the Fruits and Nut Crops PHI table, in the definition of PHI add "to wait" between "days" and "between".
- f) Add a Notes section for the crop group CANEBERRIES as follows:

Notes: (1) Do not apply more than 2 qts. of product per application and no more than 5 qts. of product per acre per season. (2) To avoid illegal residues, allow a minimum of 7 days between the last application and harvest.

- g) For Cherries, revise the number of applications for control of Leafhoppers to 3 rather than 3-4. Also, delete the first NOTE "Do not make more than 3 applications per season" since this contradicts the Cherry Fruitfly directions, which call for 3 to 4 applications. Renumber the remaining NOTES for this crop and add "To avoid illegal residues," before "allow a minimum of 21 days between the last application and harvest.".
- h) In the Notes for Nectarines, add "To avoid illegal residues," before "allow a minimum of 21 days between the last application and harvest.".
- i) In the Notes for Peaches, add "To avoid illegal residues," before "allow a minimum of 21 days between the last application and harvest.".
- j) In the Notes for Plums, add "To avoid illegal residues," before "allow a minimum of 21 days between the last application and harvest.".
- k) In the Notes for Prunes, add "To avoid illegal residues," before "allow a minimum of 21 days between the last application and harvest.".
- 1) For Strawberries, for Aphids delete ", but do not make more than 3 applications per season". For Cyclamen Mites, delete "Do not make more than 3 foliar applications per season. Do not apply within 5 days of harvest or illegal residues may occur. Application may be made to plants after harvest.". For Strawberry Leafroller, delete "Do not apply within 5 days of harvest or illegal residues may occur.". Add a Notes section as follows:

Notes: (1) Do not apply more than 1 qt. of product per acre per application and no more than 4 qts. of product per acre per season. (2) To avoid illegal residues, allow a minimum of 5 days between the last application and harvest.

m) For Walnuts, for Aphids delete "Do not make more than 3 applications per season. Do not apply within 45 days of harvest

or after husts open or illegal residues may occur.". For Codling Moths, delete "Do not make more than 3 applications per season. Do not apply within 45 days of harvest or after husks open or illegal residues may occur.". Replace the current Notes with the following:

Notes: (1) Do not apply more than 3 qts. of product per acre per application and no more than 9 qts. of product per acre per season. (2) To avoid illegal residues, allow a minimum of 45 days between the last application and harvest and do not apply after husks open.

- n) Under the heading VEGETABLE CROPS, delete the underline running from after "REI-24 HOURS" to "sufficient".
- o) In the gallorage table for vegetables, for Ginseng replace the Aerial Application Minimum Gals./Acre entry of "5" with "-" since the directions for this crop stipulate ground application only. Also in this table, delete the underline under the entry for the crop Potatoes and delete (or relocate to the top of the page) the column headings appearing above the crop Sweet Corn.
- p) In the VEGETIBLES PHI table, delete (or relocate to the top of the page) the headings appearing above the crop Potatoes. Under this table, in the definition of PHI add "to wait" between "days" and "between".
- q) Throughout the VEGETABLES section, wherever they occur replace the exiting firections for Mole Crickets with the following:

Mole Crickets - 1 qt. per acre. One to two days before planting, breadcast and immediately incorporate into the top 1-2 inches of soil.

r) Throughout the VEGETABLES section, wherever they occur replace the exiting directions for Root Maggots with the following:

Root Maggots - 2-3 qts. per acre. Broadcast just before planting and immediately incorporate into the top 3-4 inches of soil.

- s) For Sweet Potatoes, delete the pest Flea Beetles, since this foliar pest will not be controlled by a preplant application to the soil.
- t) Under the FIELD CROPS PHI table, in the definition of PHI add "to wait" between "days" and "between".
- u) For INSECT CONTROL OF ORNAMENTALS, add "Repeat as necessary."

- v) For INSECT CONTROL ON ORNAMENTALS, correct "M im osa W ebw orm s:" to "Mimosa Webworms:".
- w) In the LAWN PEST CONTROL Precautions, delete the comma after "(ducks or geese)".
- x) For LAWN PEST CONTROL, after "To control pests listed below, apply recommended rates." add "Repeat as necessary.".
- y) For LAWN PEST CONTROL, for Frit Flies relocate "before treatment" to appear before "mow grass".
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

Diazinon AG500 is an emulsifiable solution which, when diluted with water according to the directions, is intended for the control of insect pests of agricultural crops and other plants. Do not use on food crops grown in greenhouses. Do not use in barns or dwellings. Do not use on livestock.

In the directions for use which follow, best control is obtained when application is made at first sign of pests. Application should be repeated only as directed to maintain control.

To avoid spray drift, do not apply under windy conditions. Avoid spray overlap, since crop of plant injury may result.

CHEMIGATION

Diazinon AG500 may be applied alone or in combination with other pesticides registered for application through sprinkler irrigation systems to cranberries. To insure compatibility, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for five minutes. If the combination remains mixed, or can be remixed readily, the mixture is compatible.

Do not apply this product through any type of irrigation system to other crops. For chemigation, apply this product to cranberries only through sprinkler irrigation systems. Do not apply this product to cranberries through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State, Extension Service specialists, equipment manufacturers, or other experts.

Do not connect the irrigation system used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments if the need arises.

Chemigation System Connected to Public Water Systems

1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

2. Chemigation systems connected to public water systems must contain a functional, reducedpressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

Sprinkler Chemigation

1. The system must contain a functional check valve, a vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check value to prevent the flow of fluid back toward the injection pump.

3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.

5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is, adversely affected.

6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

7. Do not apply when wind speed favors drift beyond the area intended for treatment:

3. Add the pre-measured Diazinon AG500 to the chemigation system supply tank and dilute with water if needed. Proper agization is reeded if Diazinon AG500 is tank mixed with other pesticides registered for sprinkler chemigation application to cranberries.

4. Start the irrigation system and bring the system up to full pressure, making certain that all sprinkler heads are functioning properly.

5. Engage the cherrigation injection or venturi system to add the diazinon to the irrigation lines.

6. Continue to run rightion system for a few minutes after supply tank is empty to allow material in the irrigation lines to reach the sprinkler heads further from the chemigation injection point.

FRUIT AND NUT CROPS

REI - 24 HOURS

Diazinon AG500 may be applied using ground or aerial application equipment as specified in the following Table. This Table indicates the minimum amount of water that can be used for various methods of amplication. The rate of Diazinon AG500 for aerial spray or concentrated spray applied to fruit trees by ground equipment is based on a dilute full cover spray applied with conventional ground equipment m a rate of 300-490 gals. of water per acre. The specific amount of product to be used appears under separate directions for use for each crop. If the Rate calls for 1 pt. of Diazinon AG500 in 100 gals. of water, this amounts to 3-4 pts. of product per acre when applied at the usual dilute ground spray volumes of 300-400 gals. of water per acre. In no case should the amount of product used per are exceed the maximum amount per acre per application that is specified in the Timing/Special Directions for individual crops.

Note: To protect bees, do not apply to fruit trees when trees or substantial numbers of weeds in the orchard are in bloom.

ALMONDS (CA only): San Jose Scale, Parlatoria Scale - $1-1\frac{1}{2}$ pts. + 2-3 gallons dormant oil or 1-1 $\frac{1}{2}$ gallons superior type oil in 100 gallons of water. Apply as a dormant spray. Do not apply more than 6 pts. of diazinon or 9 gallons of oil per acre.

APRICOTS: Aphids, Brown Mites (Clover Mites), Two-spotted Spider Mites, Olive Scale Crawlers, San Jose Scale Crawlers - 1 pt. in 100 gallons of water. Apply as infestations occur. Repeat application after 14 days if necessary. Olive Scale Crawlers - ½ pt. + 1½ gallons of light medium horticultural oil per 100 gals. of water. Apply when scale crawlers are present. Apricot Mealybugs - 1 pt. per 100 gallons of water. Apply as a cover spray from petal fall to June. Allow 14 days between applications.

Notes: (1) Do not apply more than 4 pts. of product per acre per application and no more than 12 pts. of product per acre per season. (2) To avoid illegal residues allow a minimum of 21 days between the last application and harvest.

CANEBERRIES (CA, OR and WA only) (Blackberries, Boysenberries, Dewberries, Loganberries, Raspberries): Leafhoppers, Thrips, Aphids, Two-spotted Spider Mites, Raspberry Sawflies, Raspberry Fruitworms - 1 qt. per acre. Apply as insects occur. Repeat applications after 14 days if necessary. Do not make more than 5 applications per season. Do not apply within 7 days of harvest or illegal residues may occur. Apply in a minimum of 100 gallons of water per acre (200 gals. per acre maximum.) For raspberry fruitworms, make one application when blossom buds separate. Make a second application immediately before blossoms open. Dryberry Mites - 1-2 qts. per acre. Apply as a domant spray in the early Spring when canes are still on the ground and buds are closed. Make a second application when buds are well developed but still closed. Apply in a minimum of 100 gallons of water per acre. Do not apply within 7 days of harvest or illegal residues may occur.
