Update CSF/replacement diazinon source

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
  - a. In the Environmental Hazards, delete the sentence beginning "If waterfowl (sucks or geese)..." since this pertains to the now deleted use on lawns.
  - b. After the crop Walnuts, delete "NOTE: For all the above uses, do not apply more than a total of 9 qts. of product per acre per season.". This could be misconstrued to mean that that limitation applies to all the fruit and nut crops. Retain the heading "Notes" and it two associated items that appear directly under the crop Walnuts.

- c. In both the minimum gallonage table and the PHI table for Vegetable Crops, revise "Casabas" to revise "Casaba Melons" and revise "Crenshaws" to read "Crenshaw Melons".
- d. In the Notes under the PHI table for Vegetable Crops, revise the second item to omit reference to the now deleted uses on beans and peas, i.e., revise this item to read: "2) To Protect Bees: Foliar applications of this product should not be made to corn during the pollen shed period.".
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

The Basic Confidential Statement of Formula (CSF) dated June 14, 2001 and the Alternate CSF dated September 14, 2001 which identify replacement diazinon source Manufacturing Use Products are acceptable and have been added to this product's registration file.

#### **ENVIRONMENTAL HAZARDS**

This product is highly toxic to birds, fish and other wildlife. Sirds, especially waterfowl, feeding or drinking on treated areas may be idlied. Do not exceed maximum permitted label rates. Rates above those recommended significantly increase potential hazards to birds, especially waterfowl. Avoid overlapping of sprays, it waterfowl (ducks or geese) can be expected in the treated area after treatment (except spot treatments), apply at least 1/4 inch of water immediately after spraying this product, however stop watering before puddling occurs. Keep out of lakes, streams, ponds, tidal manshes and estuaries. For trensstrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to squatic organisms in neighboring areas. Shrimp and crab may be idlied at application rates recommended on this label. #### **AGRICULTURAL USE REQUIREMENTS**

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on tarms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. If burned, stay out of smoke.

For minor splits, leaks, etc., follow all precautions indicated on this label and clean up immediately. Take special care to avoid contamination of equipment and facilities during cleanup and disposal of wastes. #### **GENERAL INFORMATION**

Diazinon AG600 is an emulsifiable solution which, when diluted with water according to the directions, is intended for the control of insect pests of agricultural crops. Do not use on crops grown in greenhouses. Do not use in barns or dwellings. Do not use on livestock.

In the directions for use which follow, best control is obtained when application is made at first sign of pests. Application should be repeated only as directed to maintain control.

To avoid apray drift, do not apply under windy conditions. Avoid apray overlap, since crop or plant injury may result.

**Work Safety Rules** 

REPEATED EXPOSURES TO CHOLINESTERASE INHIBITORS SUCH AS ARE CONTAINED IN THIS PRODUCT MAY, WITH-OUT WARNING, CAUSE PROLONGED SUSCEPTIBILITY TO VERY SMALL DOSES OF ANY CHOLINESTERASE INHIBITOR.

Note: The California Department of Agriculture has set a 5-day reentry period for diazinon on grapes, peaches, and nectarines. Five days should elapse between the time of application and the time a worker may enter the field to engage in any activity requiring substantial contact with treated foliage. When a mixture of two or more organiphosphate pesticides are applied in combination, the interval should be prolonged by adding to the largest applicable interval an additional 50% of that interval.

#### CHEMIGATION

APPLICATION THROUGH AN IRRIGATION SYSTEM (CHEMIGATION) - CRANBERRIES ONLY.

Diazinon AG500 may be applied alone or in combination with other posticides registered for application through sprinkler infigation systems to cranberries. To insure compatibility, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for five minutes, if the combination remains mixed, or can be remixed readily, the mixture to compatible.

Do not apply this product through any type of irrigation system to other crops. For chemigation, apply this product to cranberries only through aprinted irrigation systems. Do not apply this product to cranberries through any other type of irrigation system.

Crop injury, tack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts.

Do not connect the irrigation system used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments if the need erises.

#### Chemigation System Connected to Public Water Systems

- Public water system means a system for the provision to the public of piped water for human consumption if such system
  has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the
  year.
- 2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pasticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

#### Sprinkler Chemication

- The system must contain a functional check valve, a vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- The impation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

#### Operating Instructions

- 1. Determine the acreage to be treated by the sprinkler system.
- Measure the appropriate amount of Diazinon AG500 needed to treat the acreage to be treated. Refer to the specific directions for use for cranberries for the application rate and the amount of water per acre.
- Add the pre-measured Diazinon AG500 to the chemigation system supply tank and dilute with water if needed. Proper agitation is needed if Diazinon AG500 is tank mixed with other pesticides registered for sprinkler chemigation application to cranbernes.
- Start the impation system and bring the system up to full pressure, making certain that all sprinkler heads are functioning properly.
- 5. Engage the chemigation injection or venturi system to add the diazmon to the imigation lines.
- Continue to run irrigation system for a few minutes after supply tank is empty to allow material in the irrigation lines to reach the sprinkler heads further from the chemigation injection point.

#### FRUIT AND NUT CROPS

REI - 24 HOURS

Diazinon AG500 may be applied using ground or aerial application equipment as specified in the following Table. This Table indicates the minimum amount of water that can be used for various methods of application. The rate of Diazinon AG500 for aerial applied to concentrated applied to fruit trees by ground equipment is based on a dilute full cover spray applied with conventional ground equipment at a rate of 300-400 gals, of water per acre. The specific amount of product to be used appears under separate directions for use for each crop. If the Rate calls for 1 pt. of Diazinon AG500 in 100 gals, of water, this amounts to 3-4 pts. of product per acre when applied at the usual dilute ground spray volumes of 300-400 gals, of water per acre, in no case should the amount of product used per acre exceed the maximum amount per acre per application that is specified in the Timing/Special Directions for individual crops.

Note: To protect bees, do not apply to fruit trees when trees or substantial numbers of weeds in the orchard are in bloom.

ALMONDS (CA only): San Jose Scale, Paristoria Scale - 1-1 1/2 pts. + 2-3 gallons dormant oil or 1-1 1/2 gallons superior type oil in 100 gallons of water. Apply as a dormant spray. Do not apply more than 6 pts. of diazinon or 9 gallons of oil per acre.

APRICOTS: Aphide, Brown Mites (Clover Mites), Two-spotted Spider Mites, Olive Scale Crawlers, San Jose Scale Crawlers - 1 pt. in 100 gallons of water, Apply as infestations occur. Repeat application after 14 days if necessary. Olive Scale Crawlers - 1/2 pt. + 1 1/2 gallons of light medium horticultural oil per 100 gals, of water, Apply when scale crawlers are present, Apricot Mealybugs - 1 pt. per 100 gallons of water. Apply as a cover spray from petal fall to June. Allow 14 days between applications.

Notes: (1) Do not apply more than 4 pts. of product per acre per application and no more than 12 pts. of product per acre per season. (2) To avoid liegal residues allow a minimum of 21 days between the last application and harvest.

CANEBERRIES (CA, OR and WA only) (Blackberries, Boysenberries, Dewberries, Loganberries, Raspberry Loganberries, Raspberry Sawfiles, Raspberry Fruitworms - 1 qt. per acre. Apply as insects occur. Repeat applications after 14 days if necessary. Do not make more than 5 applications per sessor. Do not apply within 7 days of harvest or flegal residues may occur. Apply in a minimum of 100 gallons of water per acre (200 gals. per acre maximum.) For raspberry fruitworms, make one application when blossom buds separate. Make a second application immediately before blossoms open. Dryberry Mites - 1-2 qts. per scrs. Apply as a domaint apray in the early Spring when canes are still on the ground and buds are closed. Make a second application when buds are well developed but still closed. Apply in a minimum of 100 gallons of water per acre. Do not apply within 7 days of harvest or flegal residues may occur.

Raspberry Crown Borers (Raspberry Root Borers) - 2 qts. per acre. Apply a single application in a minimum of 100 gallons of water per acre as a drench to the crown and lower canes in the Spring before buds break.

Notes: (1) Do not apply more than 2 qts. of product per application and no more than 5 qts. of product per acre per season. (2) To avoid litegal residues, allow a minimum of 7 days between the last application and harvest.

CHERRIES: Eyespotted Bud Moths, Fruit Tree Leafrollers - 1 pt. in 100 gallons of water. Apply in cover sprays as infestations occur beginning at petal fall. Repeat application after 7 days if necessary. Leafhoppers - 1 pt. in 100 gallons of water. Make 3 applications beginning at petal fall and continuing through the growing season as infestations occur. Allow 7 days between applications. Cherry Fruitfiles - 1/2-1 pt. in 100 gallons of water. Make 3-4 applications beginning when adult files begin to emerge and repeating at 10 day intervals. Black Cherry Aphlds - 1 pt. in 100 gallons of water. Apply as a cover spray when aphids appear. Repeat application after 10 days if necessary. Sen Jose Scale Crawlers - 1 pt. in 100 gallons of water. Apply during the pre-prink stage or when crawlers first appear. Cherry Rust Mites - 1/2-1 pt. in 100 gallons of water. Apply to trees as a single supplemental spray after harvest.

Notes: (1) Do not apply more than 4 pts. of product per acre per application and no more than 12 pts. of product per acre per season. (2) To avoid liegal resides, allow a minimum of 21 days between the last application and harvest.

CRANBERRIES: Blackheaded Fireworms (Rhopobota naevana) - 2 cts. in a minimum of 15 gals, of water per acre for ground application and up to 400 gals, of water per acre for chemigation. Apply to larval stage. Pheromone trap captures and sweep monitoring may be used to optimize treatment timing. Repeat application after 14 days if necessary. A maximum of 6 applications per season is permitted. Cranberry Fruitworms - 2-3 cts. in a minimum of 15 gals, of water per acre for ground application and up to 400 gals, of water per acre for chemigation. Cranberry growth stage and/or berry inspection for eggs may be used to optimize treatment timing; consult your local extension agent or pest management adviser. Repeat application every 14 days, as needed. A maximum of 4 applications per season is permitted for the 2 ct. rate.

Notes: (1) Do not apply more than 12 cts. of product per scre per season. (2) To avoid illegal residues, allow a minimum of 7 days between the last application and harvest. (3) This product may be applied to cranberries through sprinder irrigation. Refer to the Chemigation section for specific chemigation directions for use. (4) Do not use water from irrigated or flooded cranberry bads for drinking purposes or to irrigate crops other than those appearing on EPA approved diazinon labels.

GRAPES: Pacific Spider Mites, Leafnoppers, Grape Berry Moths, Grape Leaffolders, Omnivorous Leafrollers, Aphids, Spider Mites - 1-2 pts. per acre in a minimum of 100 gals, of water. Apply as pest occurs as a thorough cover apray. Repeat application after 7 days if necessary. <u>Orosophila app. - 6 fl. oz. per acre in a minimum of 100 gallons of water (300 gal. of water maximum). Apply as pest occurs as a thorough cover apray. Repeat application after 7 days if necessary.</u>

Notes: (1) Do not apply more than 2 pts. of product per acre per application and no more than 10 pts. per acre per season. (2) To avoid illegal residues, allow 26 days between the last application and harvest.

NECTARINES: Oriental Fruitmoths - 1 pt. in 100 gallons of water. Apply at 100% petal fall. Make 2 additional applications at 10-15 day intervals. Time the last application to peak adult flight. Aphids, Brown Mitee (Clover Mitee), Two-spotted Spider Mitee, Olive Scale Crawlers, San Jose Scale Crawlers, Peach Twig Borers - 1 pt. In 100 gallons of water, Apply as intestations occur. Repeat application after 14 days if necessary.
