

CAUTION

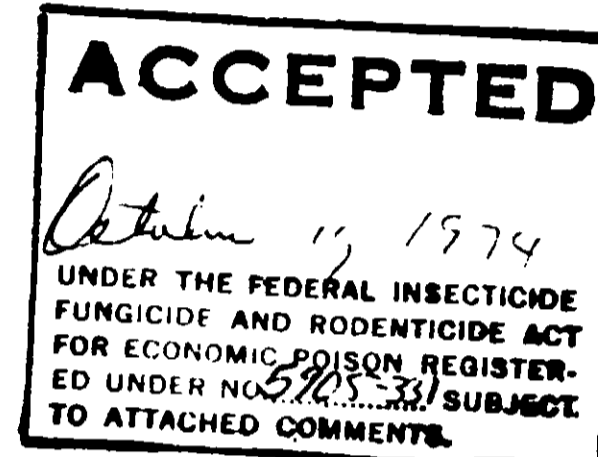
Sulphur will cause severe fruit and leaf injury to sulphur-sensitive crops. Sulphur may burn foliage and fruit during periods of high temperature and under certain climatic conditions. Do not apply sulphur to sensitive crops when shade temperatures exceed or are likely to exceed 90°F.

Do not use sulphur on any crop unless local use has proven safe.

Consult State Agricultural Experiment Stations or State Agricultural Extension Service for additional information, as the timing number and rate of applications needed will vary with local conditions.

RECOMMENDATIONS

PEANUTS: Peanut Leaf Spot and Boron Deficiency.

NOTE: A fungicide without Boron should be used for leafspot control during the remainder of the season.

NORTH CAROLINA: Make one application only during July or August at the rate of 15 pounds per acre.

VIRGINIA, FLORIDA, GEORGIA and ALABAMA: Make one application only at early bloom stage at the rate of 15 pounds per acre.

CAUTION: Overlapping of dust on rows may result in severe injury.
