It is suitable for use in conventional hydraulic sprayers and airplane sprayers. For aerial application, use a minimum of 1 1/2 gallons of spray per acre. For ground application use a minimum of 5 gallons of finished spray per acre.

Apply Permet 5-2 to cotton as shown in the chart below, using sufficient spray to OBTAIN FULL COVERAGE OF FOLIAGE. Timing and frequency of spraying should be based upon insect populations reaching local acconomic thresholds. Apply as required by scouting reports, usually at 5 to 7 day intervals.
