#### CROPS:

SMALL GRAINS NOT UNDERSEEDED WITH A LEGUME (BARLEY, OATS, WHEAT, RYE): See table for recommended use rates.

Spray when weeds are small after grain begins tillering but before boot stage (usually 4 to 8 inches tall). Do not apply before the tiller stage nor from early boot through milk stage. To control large weeds that will interfere with harvest or to suppress perennial weeds, preharvest treatment can be applied when the grain is in the dough stage. small and com is 5 to 18 inches tall. When com is over 8 inches tall, use drop nozzles. Do not apply from tasseling to dough stage. If corn is growing rapidly and temperature and soil moisture content is high, use 1/3 pint per acre rate to reduce possibility of crop damage. Higher volumes of up to 400 gallons per acre are necessary where the brush is very dense and over 6 to 8 feet high. Applications are more effective when made on actively growing plants. Treatment should not be made during time of severe drought or in early Fall when leaves lose their green color. Hard to control species may require re-treatment next season.

TREE INJECTION: For the control of unwanted hardwoods such as elm, oak, hickory, and sweetgum in forest and other non-crop areas, apply undiluted Weed Rhap® A-6D by injecting 2/3 ml through the bark, using one injection per inch of trunk diameter measured at breast height (4 1/2 feet). For harder to control species (ash, maple, dogwood), use 1-1/3 ml of undiluted Weed Rhap® A-6D per injection. All injections should be as near the root collar as possible and should be evenly spaced around the trunk.
