

- This product provides "preemergence" control of crabgrass (including the large, smooth and southern species) when applied prior to the emergence of crabgrass from the ground in established lawns and ornamental turfs.
- It can also provide "early postemergence" control of crabgrass during the early stages of crabgrass growth after the crabgrass has emerged from the ground; however, it is often difficult to see the very small, early stages of crabgrass in well-established lawns and ornamental turfs. Spring Applications
