Oil spray applied after October 1 may increase susceptibility of trees to cold damage and may reduce the fruit crop the following year. Oil Sprays applied in the fall may inhibit solids formulation in the juice and retard coloring of fruit and should not be applied within 60 days of anticipated harvest. Sensitive foliage may be injured.

Consult the Florida Citrus Spray and Dust Schedule, or your State Agricultural Experiment Station or State Extension Service Specialist for complete details in the spraying program best suited to your local.
