- d) We assume the product name is "Pro-Mate Bifenthrin GC 0.069 Plus Fertilizer". You may request to have "Pro-Mate Bifenthrin GC 0.069 With Fertilizer" as a alternate brand name. Please correct the name on the label.
- e) Under Directions for Use combine the sentence beginning, "Not for use on turf being grown for ... etc.", and "Not for use on sod farms ... etc., into one sentence to read similar to "Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed product or for research purposes, or in/on nurseries, or grass grown for seed".
- f) Under comments change "eliminate" to "control".
- 3. Within one year from the date of this notice submit the results of studies for the 830.6317 (one year storage stability) and 830.6320 (corrosion characteristics) studies. For the storage stability study it is recommended that the observations be made at 0, 3, 6, 9, and 12 months intervals.
- 4. Please submit three (3) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

Not for use on sod farms, nurseries, commercial greenhouses or grass grown for seed.

Do not apply by air.

Do not apply within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries, and commercial fish farm ponds.

Perimeter Application: Apply to grass area 6 to 10 feet wide around and adjacent to the structure using an application rate of 3.33 to 6.66 pounds per 1,000 square feet.

Grass Application: Broadcast PRO-MATE® BIFENTHRIN® GC 0.069% WITH FERTILIZER with suitable application equipment to ensure uniform coverage over the treatment area. Apply 3.33 to 6.66 pounds per 1,000 square feet to control the following pests.

¹ Imported Fire Ants: Control will be optimized by combining broadcast applications that will control foraging workers and newly mated fly-in queens with mound treatments (using BIFENTHRIN GL Flowable-EPA Reg. No. 279-3156) that will eliminate existing colonies.

² The higher application rate may be required to control Ants, Centipedes, Chinch Bugs, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks.

In New York, this product may not be applied to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland or drainage ditch).

In New York State, do make a single repeat application of this product if there are signs of renewed insect activity, but not sooner than two weeks after the first application.
