b. Add inhalation instructions to the first aid statement. The first aid statement must read as follows:

## FIRST AID

IF IN EYES: Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a Poison Control Center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice."

IF SWALLOWED: Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a Poison Control Center or doctor. Do not give anything by month to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-month if possible. Call a Poison Control Center for further treatment.

- c. The following statements are suggested types of information that may be included with the first aid statement, if applicable:
  - technical information on symptomatology;
  - Use of supportive treatments to maintain life functions;
  - medicine that will counteract the specific physiological effect of the pesticide,
  - company telephone number to specific medical personnel who can provide specialized medical advice.
- d. The Storage and Disposal statements must be modified to read as follows:

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store out reach of children in original container.

PESTICIDE CONTAINER DISPOSAL: Do not reuse container.

Rinse thoroughly before discarding in trash."

e. Revise the precautionary statement as follows:

Fatal if absorbed through skin. Corrosive. Causes irreversible eye damage or skin burns. Harmful if swallowed or inhaled. Avoid breathing vapor. Do not get in eyes, on skin or on clothing. Wear goggles or face shields. Wear protective clothing and rubber gloves. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

f. Revise the signal word DANGER to include the word "POISON" and the "SKULL and CROSSBONES symbols. Note that the skull and crossbones symbol be printed in RED INK.

- g. Expand the heading to read "PHYSICAL & CHEMICAL HAZARDS." In addition, the physical & chemical statement must be separate from the precautionary statement.
- 3. Submit three (3) copies of your final printed labeling, with the changes referred to above, before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.
