DIRECTIONS FOR USE

PEPPERS: Aphids. Use 25-40 lbs. per acre when insects first appear, repeating as necessary. Do not apply within 5 days of harvest.

STRAWBERRIES: Aphids, Two-Spotted Mites. Use 20-30 lbs. per acre when pests first noted. Repeat as necessary. Thorough underleaf coverage is essential for good control. Do not apply within 5 days of harvest.

CELERY: Aphids, Flea Beetles. Use 10-12 lbs. per acre when insects first appear, repeating as infestations warrant. Do not apply within 7 days of harvest.


LETTUCE: Aphids, Dipterous Leaf Miners. Use 10-12 lbs. per acre when insects are first noted. Repeat applications as infestations warrant. Do not apply within 10 days of harvest.

SPINACH: Aphids, Dipterous Leaf Miners. Use at 10-12 lbs. per acre when insects are first noted. Repeat applications as necessary. Do not apply within 10 days of harvest.

CABBAGE, CAULIFLOWER, BROCCOLI: Aphids, Diamond Back Moths, Imported Cabbage Worms. Use at 20-25 lbs. per acre when insects first noted. Repeat applications as necessary. Do not apply within 7 days of harvest on Cabbage or within 5 days of harvest on Cauliflower and Broccoli.

CORN: Aphids, Corn Earworm. Use at 30-40 lbs. per acre. Do not apply within 2 days of harvest. Do not feed treated forage to animals being finished for slaughter within 2 days of treatment.
