DIRECTIONS FOR USE — Dexaclor 35-35 is an agricultural fungicide for control of damping-off of sugar beet seedlings caused by Pythium, Aphanomyces and Rhizoctonia fungus species. Dexclor 35-35 is compatable with most commercial insecticides recommended for seed and soil treatment and may be applied in combination with them.
