DIRECTIONS FOR USE

READ ENTIRE LABEL. USE STRICTLY IN ACCORDANCE WITH CAUTIONS AND DIRECTIONS AND WITH APPLICABLE STATE AND FEDERAL REGULATIONS.

This product is an agricultural pesticide for application by ground or air for the below indicated uses.

Begin applications at first sign of insects. Repeat as necessary.

BROCCOLI, BRUSSELS SPROUTS, CAULIFLOWER, CABBAGE: Aphids, Diamond-Back Moths — Use 40 lbs. per acre. Do not apply within 3 days of harvest.

PEPPERS: Aphids, Leafminers—Use 25 lbs. per acre. Do not apply within 1 day of harvest.

GRAPES: Leafhoppers, Leafrollers — Use 40 lbs. per acre. Drosophila, Thrips—Use 25 lbs. per acre. Do not apply within 4 days of harvest.

LETTUCE, SPINACH, TURNIP GREENS: Aphids, Armyworms — Use 40 lbs. per acre. On **HEAD LETTUCE**—Do not apply within 3 days of harvest. Do not apply within 14 days of harvest on **LEAF LETTUCE, SPINACH, and TURNIP GREENS.**

PEACHES: Mites, Oriental Fruit Moth — Use 40 lbs. per acre. Drosophila — Use 50 lbs. per acre. Codling Moths — Use 80 lbs. per acre, apply at petal fall and every 10 to 14 days thereafter until control is achieved. Orange Tortrix — Use 80 lbs. per acre. Do not apply within 4 days of harvest.

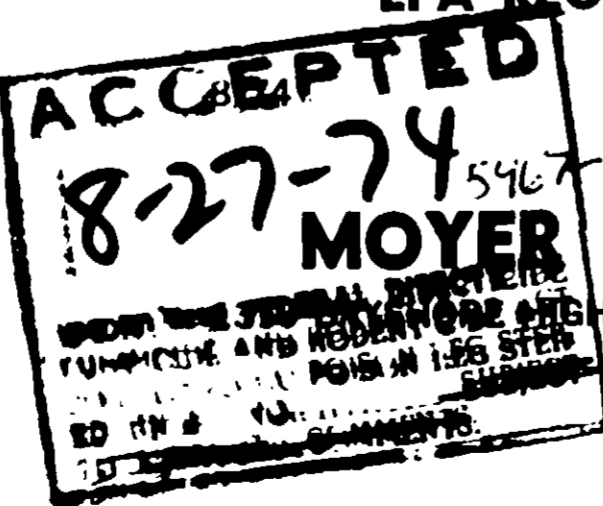
