### DIRECTIONS FOR USE Continued

Do not apply under conditions involving possible drift to food, forage or other plantings that might be damaged or the crops thereof rendered unfit for sale, use or consumption.

This product is an agricultural pesticide for application by ground or air for the below indicated uses:

**APPLES, PEARS:** Fire-Blight — 25-30 lbs. per acre. Apply at 3-7 day intervals during bloom and when blight conditions threaten. No time limitation. Do not use on Arjou, Comice or Seckel Varieties of pears.

Do not apply to pears when trees are wet — russeting may occur.

**CELERY:** Early and Late Blight — 40-60 lbs. per acre. Apply at 7-10 day intervals as conditions warrant near harvest. No time limitations before harvest.

**WALNUTS:** Blight — 35-50 lbs per acre. Make first application when 1% pistillate blossoms showing; make 2nd application when 10-20% pistillate blossoms showing. No time limitations before harvest.

### STORAGE AND DISPOSAL

**PROHIBITIONS:** Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Keep product dry in closed container. Do not use empty container for any other purpose.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product are to be disposed of on-site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
