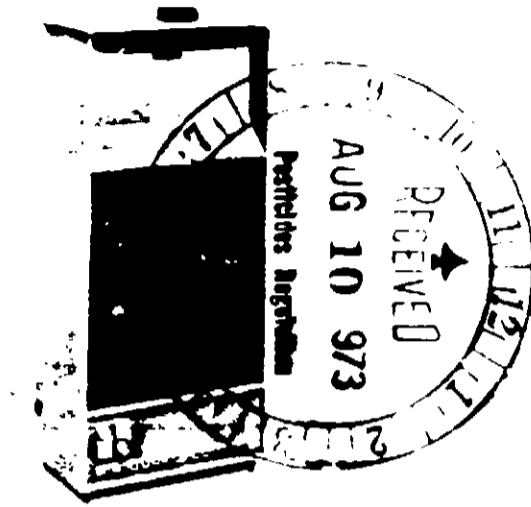

Pyrethrins	0.9
*Piperonyl butoxide, technical	9.0
Petroleum distillate	10.1
Inert Ingredients	80.0

B.V.T. Konk Aerosol Insect Killer

B.V.T. Konk is an effective aerosol insecticide for use in food handling establishments, hospitals, motels, factories, stores, restaurants, schools, poultry houses, stables, kennels, farms, dairies and washrooms.

For use with Syncro-Mist, Air Guard Control Battery Variable Time B.V.T. Dispenser. One automatic unit should be installed for each 6000 cubic feet of space to be treated. The Syncro-Mist B.V.T. dispenser activates B.V.T. Konk's valve every 7 1/2 minutes and delivers 50 milligrams (mg.) of total product. After two (2) hours of operation sufficient insecticide is suspended in the air to kill a proportion of the listed insects present and with continued use reduce further annoyance.

Usually the effectiveness of B.V.T. Konk will be noticeable within one hour after the dispenser is activated, and if less than 24 hour control is required, the dispenser should be set to start one hour before control is required and run one hour after control is established.

Conditions such as air change rate, shape of space treated, humidity and temperature affect insect activity and control - therefore, one unit per 6,000 cubic feet may be considered as the average. As with any method of insect control, improved performance is achieved when good sanitary practices are used. This 12 oz. can of B.V.T. Konk contains approximately 6600 shots and therefore, will operate for a total of 825 hours or about one month on a 24 hour basis or about two months on a 12 hour basis. Change container accordingly.
