Because of its low foam, minimal foam build-up and rapid foam dissipation, this product does an outstanding job in bottling and canning operations where foam must be controlled.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### Equipment Sanitation:

Preclean equipment with cold or lukewarm water. Fill with the solution at a concentration of 2 oz. of this product per 10 gal. of water. (provides 25 ppm titratable iodine.) After 5 minutes, drain off solution.

#### Tank and Vat Sanitation

Preclean with cold or tepid water. Add solution containing 2 oz. of this product per 10 gal. of water (25 ppm titratable iodine). After 5 minutes, drain off solution.

#### Wall, Floor, Conveyor Sanitation

Clean daily with 2 oz. this product per 10 gal. of water (25 ppm titratable iodine).

Clean weekly or at end of batch-run with solution of 4 oz. of this product per 10 gal. water (50 ppm titratable iodine) and rinse with potable water
