3. For storage stability, submit the results of analyses for the active ingredients from three production batches of your product. Test the product at the beginning when freshly prepared, and at monthly intervals for a period of 1 year under storage conditions similar to those to which the product will be exposed during marketing and distribution in channels of trade, and during use. You cannot reference storage stability data for a concentrate or intermediate which you use as a source of the active ingredient contained in your product.

On an interim basis the Agency will accept the results of an accelerated storage stability study conducted with your product. Submit the results from three batches maintained at 50 °C and analyzed at the beginning, and at 30 and 60 days. The completed study must be submitted within 14 months of the date of this Registration Notice.

4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

This product will kill fleas up to 14 days and ticks up to 7 days on dogs and cats.

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not spray in face, eyes, or on genitalia. Repeat as needed.

For cats apply at the rate of one second per pound of body weight. For dogs apply at the rate of 2 seconds per pound of body weight for thin or short-haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame. Store above 32°F and protect from freezing.

Disposal: Do not re-use empty container. Wrap original container in several layers of newspaper and discard in trash. ✓
