

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**For Houseflies, Mosquitos and Gnats:** Close all windows and doors. Spray freely toward ceiling in all directions until room is filled with mist, then leave room. Keep doors closed for at least 15 minutes. Ventilate the room when treatment is completed.

**FOR WASPS:** Applications should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contact as many insects as possible. Repeat as necessary.

**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.
