An initial slug addition of 2.9 to 7.3 fluid ounces of Chemcide C per 1000 gallons of water to provide a concentration of 24 to 60 parts per million of Chemcide C, based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.
