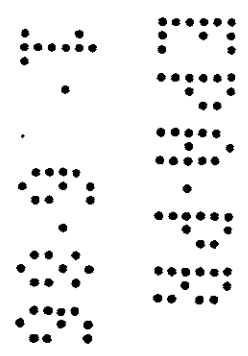

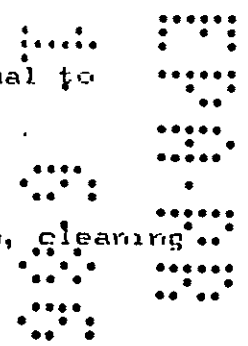
If on skin: Wash with plenty of soap and water. Get medical attention if irritation persists.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Apply only to established turf. Apply 2.8 to 3.75 lbs/1000 sq. ft. for pre-emergent control of crabgrass. Does not control established weeds. Apply before weeds germinate. Water after application to wash chemical into turf. Apply 1.9 to 3.75 lbs./sq.ft. 6 to 8 weeks later for longer control period.

STORAGE AND DISPOSAL

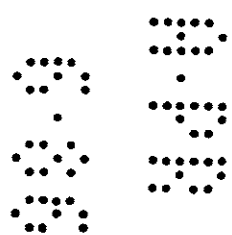
Storage: Store in original container only. In case of leak or spill, contain material and dispose of waste.
