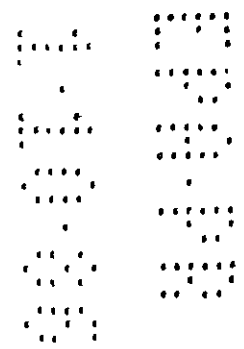

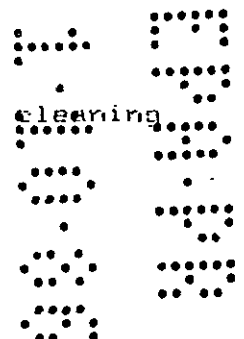

DIRECTIONS FOR USE

Apply only to established turf. Apply 3-3/4 to 5 lbs./1000 sq. ft. for pre-emergent control of crabgrass. Does not control established weeds. Apply before weeds germinate. Water after application to wash chemical into turf. Apply 2-1/2 to 5 lbs./sq.ft. 6 to 8 weeks /a/cr. for longer control period.
