DIRECTIONS — APPLY WITH SPREADER

LAWNS: For control of CHINCH BUGS apply at the rate of 15 pounds per 2500 square feet; as soon as the pest appears. Repeat in 7 to 10 days if necessary.

Granular Chinch Bug Killer applied at the above rate also efficiently controls Sod Webworms, ants, fleas, chiggers and CLOVER MITES that infest lawns.

In the New York Metropolitan area, Chinch Bugs have one generation in June and a second in August. Consult your Extension Service Specialist as to exact timing of applications.

For control of JAPANESE BEETLE GRUBS, EUROPEAN CHAFER GRUBS, and SOUTHERN CHAFER GRUBS apply at the rate of 15 pounds per 1685 square feet.

For Grub control, apply anytime between late July and early October. For control of HYPERODES WEEVIL (New York State only), apply at the rate of 15 pounds per 1850 square feet. Treat problem areas in mid April and again in mid May.

NOTE: After application sprinkle the lawn thoroughly to wash the insecticide off the grass and on to the turf. Keep children and pets off treated area until lawn has been watered and completely dried.

CAUTION
