GENERAL CLASSIFICATION**

**SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN
SHORT BURSTS.**

To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Spray directly on the insects. Repeat as necessary.

To Kill Cockroaches, Ants and Crickets: Spray directly on the insects. Repeat as necessary.

To Kill Carpet Beetles: Spray directly on the insects. Repeat as necessary.

To Kill Exposed Forms of Confused Flour Beetles, Sawtoothed Grain Beetles, and Rice Weevils: Spray directly on the insects. Repeat as necessary.

To Kill Sowbugs, Centipedes, Firebrats and Spiders: Spray directly on the insects. Repeat as necessary.

To Kill Fleas and Brown Dog Ticks: Remove and destroy old pet bedding. Spray thoroughly on pet's skin and baseboards. Wash and disinfect pet's bowl, tank and oral areas of furs. Repeat as necessary. Do not spray animals. Put fresh bedding in pet's quarters after spray has dried. Also treat dogs and cats with registered flea and tick control product before allowing them to enter treated area.
