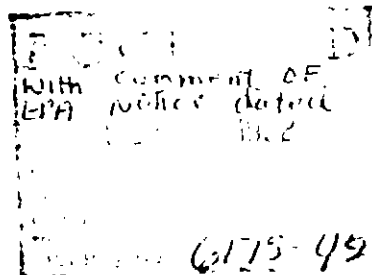

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Remove cap and insert sprayer. Cover animal's eyes with hand and with a firm, fast stroke to get proper spray mist, spray head, ears and chest until damp. Rub into face around mouth, nose and eyes with finger tips. If spraying noise disturbs dog during facial application, spray cotton ball and rub these areas. DO NOT spray directly into eyes, nose or mouth. Spray neck, middle and hindquarters, finishing dogs legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. For long haired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind your hand. Repeat treatment as needed.

SURFACE REPELLENT: Spray on places where flies, gnats and other insects gather or enter such as pet sleeping quarters, picnic tables, cat litter trays, bird cages, and kennels, around windows, doors, baseboards, wall cracks and local areas of floors. If insects are present, spray lightly into the air. Repeat treatment as needed.

## STORAGE AND DISPOSAL

STORAGE: Do not contaminate feed or foodstuffs by storage or disposal.  
DISPOSAL: Do not reuse empty container. Wrap empty container and put in trash collection.
