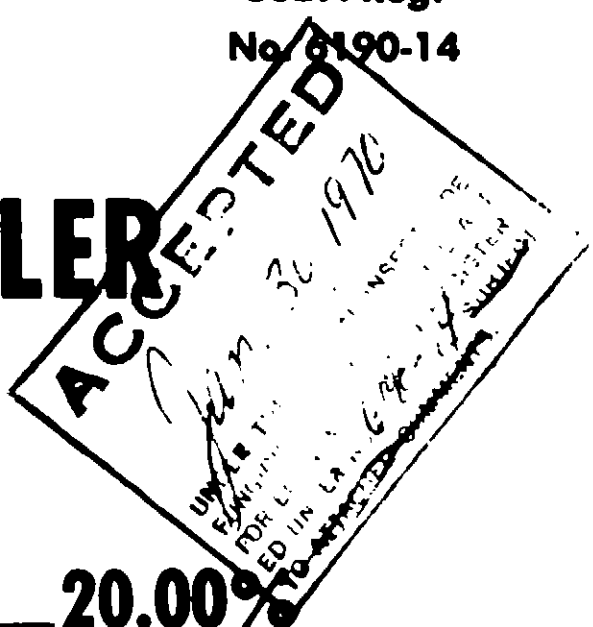

## A WEED AND GRASS KILLER NON SELECTIVE



### Active Ingredients:

Anhydrous Sodium Metaborate ( $\text{Na}_2\text{B}_2\text{O}_4$ )	20.00%
Sodium Chlorate ( $\text{NaClO}_3$ )	20.00%
Inert Ingredients incl. wetting agent	60.00%

### DIRECTIONS

Apply as a contact spray thoroughly wetting all parts of the plants, particularly the growing tips. Apply 1/2-1 gallon of solution per 200 to 300 square feet when the plants are young and tender (1 to 4 inches high).

So effective and economical, it is widely used by Railroads, Agriculture, Highway Commissions, Petroleum

Companies, Lumber Companies, Industrial Concerns and Cemeteries. Very effective also along drainage ditch banks, fence rows, streets, roadways, as well as highways. Also around buildings, storage yards, power lines, parking lots, refineries, pole houses, warehouses, guard rails, bridge abutments, rail sidings and similar areas where weed free surface is desired.
