DIRECTIONS

Mix 1 gallon of PIONEER BRAND 1 to 10 concentrate to 10 gallons of Diesel, Stave, Keresene or other light eil. Do not treat frozen wood, or treat in freezing weather. A temperature range of 40 to 120 degrees is satisfactory.

BRUSH TREATMENT

#1- Pour freely onto surface of wood to be treated and brush out evenly.

#2- Two or more applications should be made to all wood which is to be in contact with the soil. Allow 12 to 24 hours between applications.

#3. For each application, use approximately 1 gallon of the diluted material to 250 sq. ft. of wood to be treated.

SPRAY TREATMENT

#1- Use low pressure sprayer with coarse nozzle.

#2- Wet surface of wood thoroughly, avoid drip and runoff. #3. Two or more applications should be made on all wood which is to be in contact with the soil. Allow 12 to 24 hours between applications.

#4- Provide adequate ventilation and suitable protective clothing when spraying indoors.

TERMITE CONTROL

#1. Where possible dig a trench around all foundation walls and piers to a depth of 30 inches. Do not dig trench below top of footing, if this is shallower.

#2- CAUTION-Grass, trees and shrubs within three feet of the trench should be removed or protected by placing tar paper on outer wall of trench.

#3- Use 5 gallons of diluted material to 10 linear feet in trenches up to 15 inches deep and 10 gallons per 10 linear feet for deeper trenches.

FUNGUS ROTS AND DECAY

PIONEER Penta Preservative can be applied to lumber, poles, posts, and other wood products by a hot-cold bath process, by soaking, spraying, or brushing. The most effective treatment is obtained where deep penetration and high absorbtions result. Soaking or a hot-cold bath process gives better results than does spraying or brushing and should be used where possible. Fence posts should be barked and air seasoned until dry and then soaked 24 to 48 hours. The butts should be well treated. Lumber for steps, sills, etc., should be soaked for at least 12 hours. When the wood is not in ground contact two applications of brushing or swabbing may be used. The joints should be thoroughly drenched.
