ANTS, COCKROACHES, WATERBUGS, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, SAW-TOOTHED GRAIN BEETLES (aids in control of the exposed stages of the saw-toothed grain beetle which come into contact with treated surfaces). Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers.
