IF SWALLOWED: Do not induce vomiting. Call a physician or Poison Control Center.
IF IN EYES: Flush with plenty of water. Consult a physician if irritation persists.
IF ON SKIN OR CLOTHING: Remove contaminated clothing, wash skin with soap and warm water. Get medical attention if irritation persists.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as 2-PAM/protopam, may be therapeutic if used early, however, use only in conjunction with atropine. In case of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

HOW TO USE: SUPER PERMACIDE® is ready-to-use undiluted as it comes out of the container, and may be applied with either power-operated or hand sprayers. Apply as a coarse spray to infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces and waste of material. Direct spray away from people, plants, and pets. Retreat as needed. This product is only to be applied as a crack and crevice treatment or spot treatment.

INDOOR USE: COCKROACHES, ANTS, CRICKETS, SILVERFISH, SPIDERS: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door sills and frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

Applications Within Food Areas Of Food Handling Establishments: Limited to Crack and Crevice Treatment Only - Apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where Cockroaches, Ants, Crickets, Silverfish and Spiders hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Applications of this product in the Food Areas of food handling establishments, other than as a crack and crevice treatment, are not permitted.

BROWN DOG TICKS: To control these pests, thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.

OUTDOOR USE: FLIES AND MOSQUITOES: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the house. Also spray dark corners and localized resting areas (such as under eaves or porches, patios and garages) where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Do not store near heat or open flame.

PESTICIDE DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL:

Metal Containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a landfill, or by other procedures approved by State and local authorities.

Plastic Containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incinerator, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
